Child Welfare Partnership Practicum Expectations

In addition to School of Social Work internship requirements, practicums (internships)within the public Child Welfare agency are critical component of the Child Welfare Partnership Program. They provide an opportunity for students to gain valuable experience, increase their depth of understanding of the work and to begin to build a professional community with the agency.

Students are assigned a faculty advisor who will support their education development throughout the program and a faculty liaison to support their practicum placement. The Culturally Responsive Child Welfare Education Program (CRCWEP) team is here to offer additional support to students and advisors who want to collaborate in connecting your education to your Child Welfare career goals.

Culturally Responsive Child Welfare Education Program
Recruits (non-Oregon Department of Human Services
employees) – Bachelor's in Social Work (BSW)

- Bachelor's in Social Work recruit students in the Culturally Responsive Child Welfare Education Program are required to do their practicum in a public or tribal child welfare office.
- BSW partnership students with the permission of their practicum instructor are strongly encouraged to participate in Oregon Department of Human Services (ODHS Child Welfare) online trainings. Culturally Responsive Child Welfare Education Program Recruits (non-Oregon Department of Human Services employees) – Master's in Social Work (MSW)

- Master's in Social Work recruit students in the Culturally
 Responsive Child Welfare Education Program are required to
 do one of their two practicums in a public or tribal Child
 Welfare office.
- MSW recruit students may take advantage of the opportunity to complete the Child Welfare online training with the permission of their practicum instructor. This will help prepare them for their practicum, as well as, future employment with the Oregon Department of Human

Culturally Responsive Child Welfare Education Program Oregon Department of Human Services Employed Students – Bachelors in Social Work (BSW)

- Bachelor's in Social Work recruit students in the Culturally Responsive Child Welfare Education Program are required to do their practicum in a public or tribal child welfare office.
- Employees are eligible to apply for an "Employed Social Work Internship."

Culturally Responsive Child Welfare Education Program Oregon Department of Human Services Employed Students – Masters in Social Work (MSW)

- Child Welfare employees are required to do one of their two practicums in tribal or public child welfare. The practicum must be distinctly separate form their regular work, meet the School of Social Work practicum requirements and provide new learning opportunities.
- Employees are eligible to apply for an "Employed Social Work Internship."

 Employees who could benefit from an additional year of practicum by learning another aspect of the child welfare work can apply for an exception allow them to do both internships with Child Welfare.

Workday Learning Management System

Oregon Department of Human Services has a 12-month Child Welfare Program Social Service Specialist 1 (SSS1) Training Plan. Many of these courses are offered online through the Workday Learning Management System. Culturally Responsive Child Welfare Education Program students are eligible to take these offered online trainings. A Volunteer Coordinator will set up an account in Workday for interns to complete the required trainings, as well as, additional trainings. Completing these trainings not only enhances their competitiveness for employment, having completed these trainings can increase the breadth and depth of their practicum education experience. Students can count these online trainings toward their practicum hours with the permission of their practicum instructor. Please note that graduates will most likely have to complete these trainings again once hired.
